1.	Who we are?	<p>Twenty Twenty Productions Limited (Company Reg No: 03231683) whose postal address is 2 College Square, Bristol BS1 5UE ("we", "us", "our") are the production company who make First Dates Beach Club and the data controller for the purposes of casting, development, production and/or distribution of First Dates Beach Club and/or as otherwise agreed between us.</p> <p>As the data controller, we are the organisation who collects, handles, uses, stores and/or processes (together "Process") any personal data and/or sensitive personal data (together "Data") you may share with us and/or that we may receive about you.</p>
2.	About First Dates Beach Club	<p>a) References in these Terms and Conditions to: (i) "First Dates Beach Club" shall mean the programme and/or series entitled "First Dates Beach Club", (including any re-edited, re-voiced, reformatted, updated or compilation or any other versions thereof or further series or spin-offs) and/or other content; and (ii) the "Broadcaster" shall mean the broadcaster of First Dates Beach Club currently being Channel 4 (also known as Channel Four Television Corporation) together with any subsequent broadcaster.</p> <p>b) First Dates Beach Club (working title) is a Channel 4 documentary series that helps contributors to find love against the backdrop of a relaxed holiday, in a sunny Mediterranean location. Each episode will feature in-depth interviews to help the viewers get to know some of the contributors. Discreet cameras placed throughout our Beach Club will record the date from start to finish, from first impressions, through all the awkward, heart-warming and funny moments, to the end of the meal and the discussion about whether or not a second date is on the cards. Additional cameras will also be placed throughout the venue so we can follow our daters during their time at the Beach Club. After their first date, some lucky contributors will go on to have a second date with the same person, while others may be rematched with someone new.</p>
3.	Purpose of these Terms and Conditions	<p>a) These application terms and conditions ("Terms and Conditions") apply to all individuals who apply and/or otherwise indicate to us that they wish to be considered to take part in First Dates Beach Club ("apply/ing") which we propose but do not undertake to produce.</p> <p>b) By applying to take part in First Dates Beach Club, whether by completing and returning an application form to us or otherwise, you confirm that you agree to and shall comply with these Terms and Conditions.</p> <p>c) For the purposes of these Terms and Conditions, "Application Date" shall mean the date on which you apply to take part in First Dates Beach Club, whether by completing and returning an application form to us or otherwise.</p>

4.	Eligibility Requirements	<p>a) All individuals applying to take part in First Dates Beach Club MUST:</p> <ul style="list-style-type: none"> i) be aged 18 years or over as of the Application Date; ii) living in the UK as a legal resident, or be a British ex-pat legally residing in Spain; iii) be willing to travel to Spain and currently hold a valid British or European passport with a minimum of 3 months until expiry from 31st May 2025. The passport must have been issued within the last 10 years; iv) be single and not in a sexual relationship of any kind; and v) looking for love; <p>(together the “Eligibility Requirements”).</p> <p>b) By applying to take part in First Dates Beach Club, whether by completing and returning an application form to us or otherwise, you confirm and agree that you comply with all the Eligibility Requirements.</p> <p>c) If your circumstances change and you no longer meet all or part of the Eligibility Requirements, you agree to notify us promptly by email at firstdatesbeachclubcasting@twentytwenty.tv</p>
5.	Background Checks and Information Gathering	<p>a) You acknowledge and agree that we may undertake background checks as part of the casting process. You agree to provide (or assist us in obtaining) further information, documentation, references and/or evidence as requested by us for the purpose verifying you comply with the Eligibility Requirements and undertaking background checks.</p> <p>b) Participation in First Dates Beach Club will be subject to all necessary paperwork, background checks, references and/or consents as requested by us being promptly completed and returned to us (which may include without limitation information regarding your health and/or criminal and/or civil actions and/or convictions).</p> <p>c) You acknowledge that we undertake criminal record checks on contributors on First Dates Beach Club and you will complete a DBS check through PeopleCheck, a background check provider, and you shall enable PeopleCheck to have full access to such information, documentation, records and/or references as required by PeopleCheck to conduct the DBS check.</p> <p>d) If you or any member of your immediate family and/or household are currently or in the past twelve months been an employee, contractor, officer, director or agent of us, Warner Bros. International Television Production Group, the Broadcaster or anyone connected with First Dates Beach Club, you agree to notify us whether on your application form or otherwise.</p>
6.	Casting and Production Process	<p>a) All applicants for First Dates Beach Club will be assessed at our sole discretion for their suitability to be put forward to the next stage of the selection process and all decisions by us shall be final. We reserve the right to refuse any submitted application. There will be no right of appeal against any decisions taken by us on this or any matter relating to the casting and/or production of First Dates Beach Club. Unfortunately, due to the large number of applications we receive, we will only contact you if you are successful in being selected as a potential contributor for First Dates Beach Club.</p> <p>b) You accept that submission of an application form, compliance with these Terms and Conditions, receiving a phone call from a member of</p>

		<p>the production team, attending an audition and/or attending any recording days DOES NOT constitute an offer to appear on or automatically mean you will be appearing on First Dates Beach Club.</p> <p>c) We reserve the right, at our sole discretion, to stand you down and/or choose not to film with you and/or use any footage of you at any time during the casting and/or production process, even if you have been given a date to attend auditions and/or have been filmed for First Dates Beach Club.</p> <p>d) You understand that we reserve the right to vary any element of First Dates Beach Club and, even if you meet the Eligibility Requirements outlined above, we shall have no obligation to produce any episode of First Dates Beach Club, to broadcast any episode of First Dates Beach Club, or to select you as a contributor, and even if you are selected we are not obliged to include your Contribution (as defined below) in First Dates Beach Club.</p>
7.	Your Obligations	<p>a) You agree that you will not withhold from us any material fact that may in our reasonable opinion jeopardise or otherwise impact on First Dates Beach Club or which might result in publicity adverse to our good name, the Broadcaster and/or First Dates Beach Club.</p> <p>b) You confirm to us that:</p> <p>i) any information you provide to us, whether in the application form or otherwise, is truthful, complete, accurate and not misleading and you have not deceived or attempted to mislead us or the Broadcaster in any way (including but not limited to in your identity, single status, experiences, background and/or health);</p> <p>ii) by reason of your conduct (including past conduct) you shall not bring us and/or the Broadcaster into disrepute;</p> <p>iii) you agree to comply with and adhere to these Terms and Conditions;</p> <p>iv) you will notify us in the event any Data we Process about you is incorrect and/or requires updating, changing and/or correcting. Please refer to our Privacy Policy use new link which provides the relevant contact details.</p> <p>c) If you are found to have knowingly supplied inaccurate, misleading or false information to us, you acknowledge and agree that you may be immediately disqualified from the casting process and/or taking part in First Dates Beach Club.</p>
8.	Intellectual Property Rights	<p>a) If you are invited to participate in any Zoom video calls which shall be recorded or a filmed master interview as part of the casting selection and/or production process for First Dates Beach Club and in consideration of us arranging to film you (and other good and valuable consideration sufficiency of which is acknowledged by you), you agree to the photographing, recording and filming of your video call, interview, contribution and/or performance during and in connection with First Dates Beach Club ("Contribution") and the use of your Contribution (or any part(s) thereof) in First Dates Beach Club. Your Contribution may be edited into a 'sizzle reel' and provided to Channel 4 to assist with the casting and selection process.</p>

		<p>b) You grant to us all necessary rights and consents to permit us to make the fullest use of the Contribution and/or any information, photographic/video material submitted by you or filmed or recorded by us as part of your application for and/or casting selection for and participation in First Dates Beach Club (collectively referred to as the "Material(s)") for any purposes connected with the promotion and exploitation of First Dates Beach Club, and/or ancillary products, rights, services and/or in connection with us and/or the Broadcaster, in any and all media now known or hereafter invented throughout the world in perpetuity.</p> <p>c) You accept that we have the right to edit, copy, adapt and/or translate the Material(s) and/or Contribution as we see fit and you irrevocably waive the benefits of and agree not to assert any provision of law known as "moral rights" or any similar laws of any jurisdiction.</p> <p>d) You agree that we have no obligation whatsoever to return any Material(s) whether or not you are selected as a contributor for First Dates Beach Club and that we are in no way obligated to use any of the Material(s) in connection with First Dates Beach Club.</p> <p>e) You grant us the right to use your name, voice, likeness, photographs and any biographical material concerning you in First Dates Beach Club and in connection with the casting, development, production, publicity promotion and exploitation of First Dates Beach Club and/or ancillary products, services and/or rights and/or in connection with us and/or the Broadcaster, throughout the world in all media in perpetuity.</p>
9.	Confidentiality	<p>You will keep strictly confidential and will not without our prior written consent at any time publish or disclose to any person (including without limitation via the internet or any social networking sites such as Instagram, Facebook and/or Twitter) any conversation, information or photographs concerning First Dates Beach Club and/or the application, selection, filming and/or production process which comes to your knowledge nor other information relating to us, the Broadcaster or First Dates Beach Club acquired by you, other than information already in the public domain.</p>
10.	Data Protection	<p>To participate in First Dates Beach Club you will be required to give your consent to the processing of your personal and special category personal data in accordance with the Twenty Twenty Privacy Policy (https://www.twentytwenty.tv/Tv_Production_Privacy.aspx)</p>
11.	General	<p>a) The rights granted under these Terms and Conditions are freely assignable and licensable by us.</p> <p>b) Any trademarks, logos, graphics, photographs, videos and texts featured on the First Dates Beach Club Casting website and/or in First Dates Beach Club remain our intellectual property and may not be reproduced, used or represented without our express prior permission.</p> <p>c) You acknowledge and agree that neither us, the Broadcaster nor their assignees and/or licensees shall be liable for any loss, damage, injury, claim and/or disappointment suffered, by you (including but not limited to special or consequential loss, loss of reputation, trespass to property or trespass to person) in connection with your involvement in First Dates Beach Club, other than death or personal injury caused by our or the Broadcaster's (as applicable) negligence or other liability that is prohibited from being limited or excluded by law.</p>

		<p>d) You agree that you shall not be entitled to injunct or restrain the transmission of First Dates Beach Club or the use of the Material(s) and/or any programmes and/or ancillary use which includes the Material(s) (or any part of it).</p> <p>e) Failure by us to take action in respect of the breach by you of any provisions of these Terms and Conditions shall not be interpreted as constituting a waiver by us of the right to take action in future in respect of such a breach.</p> <p>f) These Terms and Conditions will be exclusively governed by and construed in accordance with the laws of England and subject to the exclusive jurisdiction of the English courts.</p>
